NARRATIVE: AS THE THREE VICTIMS WERE WALKING S/B THEY OBSERVED A SMALL BLACK SUV STOP NEXT TO THEM. TWO OFFENDERS (LATE TEENS EARLY 20'S) WEARING ALL BLACK CLOTHING WITH HOODS UP AND BLUE SURGICAL MASKS EXITED THE VEHICLE WHILE A 3RD SUBJECT STAYED IN THE DRIVERS SEAT. THE TWO OFFENDERS APPROACHED THEM, DISPLAYED HANDGUNS, PATTED THEM DOWN AND REMOVED THEIR BACKPACKS FROM THEIR BACKS.
