NARRATIVE: THE VICTIMS PARKED THEIR VEHICLE WHEN AN UNKNOWN VEHICLE PULLED UP BESIDE THEM. 3-4 SUBJECTS JUMPED OUT AND CHASED THEM. VICTIM #2 WAS ABLE TO GET AWAY BUT #1 FELL AT THE SCENE AND THE SUBJECTS STATED "DON'T MOVE OR I'LL SHOOT." THE SUBJECTS DEMANDED THE KEYS TO THE VICTIM'S CAR BUT VICTIM #1 DIDN'T HAVE THEM. THE SUBJECTS REMOVED HER BLACK MARC JACOBS PURSE CONTAINING \$400 USC AND HER SAMSUNG PHONE AND THEN FLED THE SCENE IN AN UNKNOWN DIRECTION. LOSS ESTIMATED AT \$1,000.

ONE OF THE SUBJECTS ENTERED THE VICTIM'S VEHICLE AND REMOVED A WALLET AND TWO CELL PHONES. THE SUBJECTS RE-ENTERED THE HYUNDAI AND FLED THE SCENE. LOSS ESTIMATED AT \$1,500.00.
