VI. Applicant Interviews

 Ms. Novack-Gottshall shared from her experience as Chair of the Farmers

VII. Reports:

a. Administrative Report/ Vacancies and Waitlist

Clerk Scaman reviewed with members of the Citizen Involvement Commission (CIC) the Vacancy and Chair Expiration Date Report. Concern remains for recruiting volunteers to

the Farmers Market Commission. The Village Communications Department will be developing a flyer to be distributed at Earth Fest on April 21, 2018.
