## **Reports**

### Administrative Report

Village Clerk Powell noted that all pending appointments were currently on hold. Steps going forward were discussed.

#### Marketing Subcommittee Report

Commissioner Hollinden had nothing to report. She mentioned that there were pictures and information regarding the volunteer event on Facebook.

Commissioner Schmitt exited the meeting.

## Old Business

#### Review of Outstanding Service Award Process

Chair Kelly stated that Outstanding Chair Award recipient John Shuler was tremendously moved by that recognition. He noted that there was miscommunication resulting in only members of the recognized commissions being asked to attend; next year all commissioners will be invited.

Chair Kelly was disappointed in the response regarding nominations this year. He wanted to increase interest in the event. Commissioner Hollinden suggested that a committee be formed to plan the occasion well in advance instead of CIC members rushing at the last minute. Village Clerk Powell noted that at one time this event, "Evening of Appreciation", was a dinner held at the 19<sup>th</sup> Century Club or other venue. All commission members and their spouses were invited. Perhaps something like this can be considered. Chair Kelly stated that he would add this topic to next month's agenda for discussion.

#### Status of Pending Applicants

Chair Kelly stated that as of March, the process of moving applicants forward to a Board Meeting Agenda has been difficult. He was asked by CIC Trustee Liaison Glenn Brewer to do some research regarding how other municipalities handle board and commission appointments. Although Oak Park is unique in terms of the number of commissions, all Council Manager municipalities state that the president appoints with the consent of the board. Chair Kelly was seeking clarification of that process.

Earlier today he learned that none of the candidates recommended for appointment had been placed on the July 7 Board Meeting Agenda. In response, he wrote an email to President Abu-Taleb asking for clarification and was awaiting his reply.

Plan Commission candidate Conrad Terry was discussed. Chair Kelly stated that since his appearance before the CIC in May, he has attended a meeting of the Plan Commission and has spoken with both the chair and staff liaison. His references were contacted and all gave outstanding feedback.

Candidate Adam Gill has requested to be on the wait list for Community Relations; he will be next in line after Tennille Allen, who is already on that list.

Peter Tambroni, who was interviewed in June, withdrew his application as he cannot commit to service on a commission at this time.

It was moved and seconded that Conrad Terry be recommended for appointment to the Plan Commission.
