

**Minutes of the Liquor Control Review Board

1. **Call to Order:** Chair Victoria Scaman called the meeting to order at 7:33 p.m.

2. **Roll Call:**

3. **Agenda Approval**

It was moved by Member Orzel and seconded by Member Conniff to approve the Agenda as presented. A voice vote was taken and the motion was approved.

5. **Approval of Minutes**

It was moved by Member Miller and seconded by Member Orzel to approve the minutes of the Liquor Control Review Board ("LCRB") meeting of June 30, 2015 as presented. A voice vote was taken and the minutes were approved as presented.

6. **New Business**

A. **An Ordinance Amending Chapter 3 ("Alcoholic Liquor Dealers"), Article 4 ("Term and Classification"), Section 3-4-2 ("Classification and Number of Liquor Licenses and Fees")**

The LCRB discussed the proposed ordinance and asked questions regarding the proposed time of 7:00 a.m. contained in the ordinance to allow for the sale of packaged liquor from the current 9:00 a.m. Loretta Daly provided information regarding times allowed in surrounding communities. After further discussion, it was moved by Member Orzel and seconded by Member Conniff to recommend to the Village Board adoption of an ordinance amending Chapter 3 ("Alcohol Liquor Dealers"), Article 4 ("Term and Classification") Section 3-4-2 ("Classification and

Number of Liquor Licenses and Fees”) to change the hours for the sale of packaged liquor.

B. Application of Royale Liquors, LLC d/b/a Pete’s Fresh Market for a Restaurant Class B-2 liquor license at 259 Lake Street

Byron Tsokolas of Pete’s Fresh Market spoke to the LCRB regarding Pete’s application for a B-2 liquor license. Mr. Tsokolas stated that Pete’s is requesting the license to serve beer and wine for on-site consumption within the confines of a café. The LCRB asked questions of Mr. Tsokolas concerning the general operation of the café and BASSET training for servers.

It was moved by Member Miller and seconded by Member Keeku to recommend approval of a Restaurant Class B-2 Liquor License to Royal Liquors, LLC d/b/a Pete’s Fresh Market at 259 Lake Street.
