TG gave an overview of OP Station Project

New business

- 1. Progress Center for Independent Living (PCIL)
 - o The Center connected with Forest Park Chamber would like to connect with OPRF Chamber.
 - Employment opportunities for People with Disabilities:

- Sometimes they don't do well in the interview process. Several Forest Park businesses, such as Ferrarra Pan Candy. Edward Jones Madison Ave., have been working as community partners and marketing employees to those businesses. Main Marketing for People with Disabilities and families represent a Trillion dollar market.
- People with Disabilities reliable works: Promotes an inclusive work environment and will promote the businesses. Tax breaks are available to those businesses. Trial work period 12 weeks at no cost to the business. DORS is paying the salary. Paid internship in PCIL. Intern will be shadowed by professional to help them get acclimated to the job environment. Completion of 12 weeks could present a job offer. If not, business is required to give constructive criticism with the reasons why it didn't work. Put it out the end of November. Database will be available towards the end of December.

Action Item - Help coordinate with the OPRF Chamber and encourage more businesses to join.

2. Systemic Issues -

- o For example, the State of Illinois not having a budget.
- Budget issues related to accessibility improvements. Businesses don't think they have to change.
 Issues related to accessibility always give them the option of a portable ramp. Concern over one step entrances. Steve Cutaia explained that businesses with old buildings do not have to bring their business up to current ADA standards but if they touch something have to fix it.
- Kate said that Cook County requires reasonable accommodations. So a bell with a portable ramp is very cheap.
- Larry working accessibility issues in Library; there are tables in bathroom stalls. Steve will contact Library about removing the tables.
- Steve Cutaia state that the States Attorney is responsiblie for enforcement and at the next meeting he will bring a form for filing complaints with States Attorney office.

Action Item - Recognize businesses that support People with Disabilities, those having access and holding informational sessions to bring awareness.

3. Reviewed Farmers Market Event

- Commission will want to distribute Surveys, a one-pager on the Disability Access Commission (staff will need to work with Communications on this), and coloring pages and crayons. Linda DeViller will get the information and documentation together and give to Helen to bring to the Market.
- 4. <u>WorkPlan</u> the 2016 Work Plan was moved and seconded by Commissioners Kossler and Henry to accept and was passed unanimously.
