Charley communicated that Chair Miller had asked about inviting those agencies that work with youth to come and speak on this issue, including the school district and other social service agencies. There was some discussion regarding what the current ordinance states regarding possession. Serratos communicated that students are juuling at school and has heard that students are hiding their Juul devices in creative ways. Serratos observes students juuling in the student bathrooms regularly. Serratos also thinks there is a lack of knowledge amongst staff regarding what a Juul looks like. The BOH will add this agenda item to a future BOH meeting. This will provide BOH members time to conduct research on the current Village ordinance and other supporting documents.
- B. Village Board referral to review Chapter 5-4-11 of the Village Code "Limitation on Animals per Household" as it relates to multi-family properties. The BOH viewed the Village Board comments from their June 4 meeting regarding limitations. Charley communicated that the Village Board hasn't officially "referred this item", Charley

- communicated that he will submit an agenda commentary item to the Village Board so that the Village Board can officially refer to the BOH.
