David Baker of the 300 Wisconsin Avenue block offered a report about an accident at Wisconsin and Washington

- Engineer Koperniak presented information regarding the consideration of intersections needing further traffic control studies. Four intersections were actually chosen

Evaluate and Select Three Key Intersections to improve pedestrian safety (cont.)

- Lake and Scoville
  - Oak Park Ave. and Garfield
  - Oak Park Ave. and Adams
  - Oak Park Ave. and Augusta
- The commission made requests for information to be presented at the next meeting
- Statistics concerning automobile crashes from July 2018 until the present
  - A list of possible bicycle and pedestrian improvement options including options presented in the Village Bike Plan of 2015.
6. PETITION FOR A TRAFFIC CALMING DEVICE AT THE INTERSECTION OF KENILWORTH AND LEXINGTON ST.
- Staff Commentary and Background information
- Public Works Traffic Engineer Jill Juliano presented a detailed report describing traffic patterns and conditions on the streets and walkways in the area surrounding the Kenilworth and Lexington intersection.
  - Chair Eichenberger indicated that there does not appear to be a speeding problem. He did speak about outliers such as drivers exceeding the speed limit and discussed enforcement issues.
  - Commissioner Moses inquired about traffic signal functions at the intersection of Oak Park Avenue and Garfield. Engineer Juliano described the system's present design and described possible, future alternatives.
  - Engineer Koperniak identified southbound Kenilworth as a primary route to Lincoln School at Harvard for cars and pedestrians
  - Commissioner Taylor described the high volume of pedestrians walking along Lexington as a route to Lincoln School
  - There was a discussion among the commissioners regarding safe walking routes to access Lincoln School
- Public Testimony
- April Johnson of South Kenilworth Ave addressed the commission
    - Pedestrian safety is paramount, specifically young Lincoln School students
    - The Kenilworth and Lexington intersection is one block north of Lincoln School which serves 700 school aged children.
    - Traffic extremely heavy between 7:30am and 8:00am as children arrive by bus, car and on foot. There are many adult

pedestrians as well, parents of students and commuters heading to the Blue Line.

- Traffic on Lexington is slow as many are turning onto Kenilworth
- A traffic calming measure has wide support among the neighborhood residents. The survey results were hampered by inclement weather.

## CLOSE TESTIMONY

## DISCUSSION

- Commissioner Thompson indicated agreement with the staff recommendation that the Traffic Calming issue should be tabled.
- Taylor stated his concern for pedestrian safety and spoke in favor of the installation of a four way stop at the Kenilworth and Lexington intersection.
- Commissioner Stigger agreed to table the issue but also recommended assigning a crossing guard on a temporary basis to evaluate a guard's effectiveness.
- Commissioner Katner questioned a four-way stop and favors improvement of crosswalk markings
- Improved, "European" cross walk markings are described and discussed
- Moses spoke in favor of a four-way stop
  - Katner was in agreement and indicated his support of installing a four-way stop
- Commissioners discussed the pros and cons of "tabling" the issue
- Stigger inquired about possible turn restrictions at the intersection of Oak Park Avenue and Lexington.
  - The ensuing discussion considered the pros and cons and the effect on traffic movement.
  - Chair Eichenberger noted that defaulting to motorist's options may not produce the best result for pedestrians.
  - There was a discussion about the use or non-use of marked crosswalks

<b>Abstract (briefly describe the item being reviewed):</b>  On October 17, 2018, the Village of Oak Park received a petition to install a traffic calming device on the 1150 block of Home Avenue. Resident concerns include: vehicle crashes, dangerous driving, motorists speeding on the block when Roosevelt Road is congested and construction of a Montessori school at the northeast corner of Home Avenue and Roosevelt Road which will increase traffic on the block.  At tonight's meeting, staff will present the collected traffic data, and public testimony will be taken. The Transportation Commission may concur with staff's recommendation or make a different recommendation.	
<b>Staff Recommendation(s):</b>  Staff is recommending to table the traffic calming petition for the 1150 block of Home Avenue until the fall when a new traffic study can be completed for these same blocks.

Re: Background Information Related to the Petition for the Implementation of a Traffic Calming Device on the 1150 block of Home Avenue

## Petition Submittal for the 1150 Block of Home Avenue

On October 17, 2018, the Village of Oak Park received a petition to install a traffic calming device on the 1150 block of Home Avenue. Residents representing 84.03% of the street frontage on the petitioning block signed the petition. The petition was certified as a valid petition.

Reasons provided for the petition include: vehicle crashes, dangerous driving, motorists speeding on the block when Roosevelt Road is congested and construction of a Montessori school at the northeast corner of Home Avenue and Roosevelt Road which will increase traffic on the block. A second submitted letter of explanation talks of the narrow roadway width of Home Avenue, congestion on the block due to vehicles having to wait for oncoming traffic to proceed, speeding vehicles, and the many crashes on Home Avenue at the Jewel exit and at Roosevelt Road. See Exhibit 5.2 for a copy of this petition and accompanying letter of explanation.

On May 15, 2019 the Village of Oak Park sent a notification letter to the residents on the 1150 blocks of South Maple Avenue, Wisconsin Avenue, Clinton Avenue and Kenilworth Avenue that the Village received a valid petition requesting a traffic calming device on the 1150 block of Home Avenue. Further, the Village would prefer to look at the issue in a holistic manner on the 1150 blocks in the southwest section of the Village. Their blocks are the other 1150 blocks between Harlem Avenue and Oak Park Avenue without some type of calming device. And if they feel their block should be considered they can submit a petition as well (see Exhibit 5.8 for the notification letter).

As a result of the letter, residents from the 1150 block of Wisconsin Avenue and the 1150 block of South Kenilworth Avenue contacted the Village to obtain a traffic calming petition for their blocks. Ultimately, the Village did not receive a signed traffic calming petition from either of the blocks. Therefore, only the traffic calming petition from the 1150 block of Home Avenue is being considered at tonight's Transportation Commission meeting.

See Exhibit 5.3 for written public testimony received by the Village of Oak Park regarding this item. There is 1 email opposed to the petition unless there is crash history to support a traffic calming device and 6 emails that are neutral to the petition but comment that other blocks should be included in this traffic calming discussion or mention other issues that should be addressed.

A directional twenty-four hour traffic volume and speed study was conducted on Thursday, May 2, 2019 for the 1150 blocks of South Maple, Wisconsin, Home, Clinton, and South Kenilworth Avenues. See Exhibit 5.6 page 1 for a summary of the results. Source data is also included in Exhibit 5.6 pages 3-17. Similar data was collected in 2002 & 2003 for the same blocks. A summary of the 2002 & 2003 data is also provided for historical comparison (see Exhibit 5.6 page 2).

Collision diagrams for the intersections of Home Avenue & Fillmore Street and Home Avenue & Roosevelt Road were generated. See Exhibit 5.7 for the two collision diagrams.

Next, staff completed a scoring table for the traffic calming petition. See Exhibit 5.4 for the scoring table. A numerical score is calculated for six measures that are the typical reasons for a petition to be submitted. The maximum possible score is 100 points. A minimum score of 25 points is required to bring a petition before the Transportation Commission.

Total score for the 1150 block of Home Avenue petition is 40 points. Score for the petition exceeds the minimum score necessary to submit the petition to the Transportation Commission for review and recommendation.

See Exhibit 5.5 for the blocks with existing cul-de-sacs or no access to Roosevelt Road between Harlem Avenue and Oak Park Avenue. This exhibit shows the traffic limiting devices that have been employed along Roosevelt Road.

Reviewing the 24-hour volumes for all five blocks studied in 2019 (Exhibit 5.6), the two-way average daily traffic (ADT) ranged from a low of 431 vehicles (1150 block of South Kenilworth Avenue) to a high of 1,291 vehicles (1150 block of Home Avenue). The 2019 volumes for all blocks but the 1150 block of Home Avenue fall within or below the 800 to 1,200 vehicle range for typical daily volume on residential streets within the Village of Oak Park.

The 1150 block of Home Avenue volume is 7.5% higher than upper limit for a typical residential block in the Village. However the 1150 block of Home Avenue is classified as a collector street according to the Village's Comprehensive Plan. So the 1150 block of Home Avenue is expected to service higher volumes of traffic on the block than the adjacent blocks which are classified as residential.

The 2002-2003 volume for each block studied is higher than the volume result for the same block in 2019. This is consistent with what the Village has found on many of its streets since 2008. The lower volumes are due in part to the 2008 financial crisis. Part of the decrease in vehicle volume on the 1150 block of Home Avenue can also be attributed to the ongoing Montessori school construction. As a result, there does not appear to be an issue with the volume of traffic traveling on the 1150 block of Home Avenue.

Regarding vehicular speeds, it is an accepted traffic engineering practice to set the speed limit to the 5 mile per hour (mph) increment above or below the 85th percentile speed. Village Staff holds the opinion that the majority of drivers will drive at or near the posted speed limit. In addition, it is an accepted fact that the speed indicated on speedometers can vary up to 2 percent above or below the actual speed of the vehicle.

By definition, the 85th percentile speed is the speed at which 85 percent of the vehicles are traveling at or less than. Conversely, 15 percent of the vehicles will be traveling faster than the 85th percentile speed. It has already been stated that speed limits are typically set to the 5 mph increment above or below the 85th percentile speed. This implies that it is expected that approximately 15 percent of vehicles will be traveling faster than the speed limit, if the speed limit is in the 5 mph increment below the 85th percentile speed.

Next is the review of the traffic study results regarding vehicle speeds on the 1150 blocks of South Maple, Wisconsin, Home, Clinton, and South Kenilworth Avenue. The 85th percentile speeds for all blocks in 2019 traffic study ranged between 24 mph and 28 mph. Only the 1150 block of Wisconsin Avenue has 85th percentile speeds that are slightly above the expected 25 mph, at 27 mph for two-way traffic. Based on the collected data in 2019, there does not appear to be a speeding problem on the 1150 block of Home Avenue.

For the 2002-2003 traffic study results, all of the blocks have 85th percentile speeds that are higher than the 25 mph speed limit. This previous data is noticeably different than the 2019 traffic study results. School construction on the 1150 block of Home Avenue may account for some reduction in the 85th percentile speed on that block but for not any of the other blocks. There have been no real changes to the geometry or signage on those blocks that may account for the lower 85th percentile speeds. However there was the Roosevelt Road streetscape project in the time period between the two traffic studies which may also affect vehicle speeds on the blocks.

Next, thirty-six months of vehicle crash reports covering the period of January 2016 through December 2018 were reviewed for the 1150 block of Home Avenue. Please see Exhibit 5.7 for the collision diagrams.

The number of reported crashes that occurred at the Home Avenue and Fillmore Street intersection for the thirty-six months ended December 31, 2018 totaled one. It was a right angle collision in 2018. The average daily traffic for the intersection as determined as part of the Village's 1998 area-wide traffic study was 2,527 vehicles. From this data, the 2018 crash rate for the Fillmore Street and Home Avenue intersection is calculated to be 0.361 accidents per million entering vehicles (Acc/MEV).

This crash rate is below the critical crash rate calculated for this section of the Village (south of the Eisenhower Expressway between Harlem Avenue and Austin Boulevard) as determined in the area-wide traffic study of 1998 (0.94 Acc/MEV). If an actual accident rate exceeds the critical crash rate then it is highly probable that the accidents were caused by factors other than chance.

The number of reported crashes that occurred at the intersection of Home Avenue and Roosevelt Road for the same time period totaled thirteen crashes. The average daily traffic for the Home Avenue and Roosevelt Road intersection as determined as part of the 1998 traffic study was 28,530 vehicles. The crash rate for this intersection is calculated to be 0.436 Acc/MEV which is also lower than the critical crash rate of 0.94 Acc/MEV.

In conclusion, there does not seem to be a problem with vehicle crashes on the 1150 block of Home Avenue.

Staff is recommending to table the traffic calming petition for the 1150 block of Home Avenue until the fall when a new traffic study can be completed for the same blocks. Data collection will occur after construction of the Montessori school is complete and traffic patterns have returned to a steady state. This will also give residents on the other blocks another opportunity to complete and submit a traffic calming petition to the Village if they so desire.


Dear Ms. Juliano,

My name is Eugene White, I live at [REDACTED] Home Avenue for the last 27 years. In my years at this address I have seen many accidents and dangerous driving but I have to say it is getting worse every day. We have seen Car accidents, People and Bikers getting hit by cars, parked cars getting hit and offenders leave the scene ( my car has been hit several times). When traffic is backed up on Roosevelt people decide to speed down our street. My neighbors and I have called out for them to slow down and some vehicles will stop and start arguing with us. My one neighbor has been called the N word several times. We have spoken with Officer Romero who has said he has received many complaints but there is only so much he can do. Children are walking to and from school every day and cars race down. Now they are building a Montessori school on the corner. Dear Mrs. Juliano,

Please accept this letter in request for the commission to evaluate the 1100 South Block of Home Avenue as a need for safer traffic patterns. My name is Mike Baiardo, I live at [REDACTED] Home Avenue with my wife, Beth and three kids: Quinn (8), Sofia (6) and Stella (3).

My wife and I understood that we purchased a house on a block that is used for a thoroughfare for Oak Park Residents north of I290 and west of Oak Park Ave. to get them to Roosevelt and non-residence to Jewel-Osco, 7036 Roosevelt. In my opinion, traffic patterns are similar to Lombard Avenue or East Avenue. The difference between Lombard or East and Home Avenue on this stretch of road is the street is too narrow. Residents of this street have experienced:

- Cars hitting parked cars.
- Stop and go traffic because cars are forced to let the oncoming traffic proceed.
- Bikers and pedestrians have been hit at the intersection of Roosevelt and Home.
- Speeding. Many cars speed from the Berwyn side of Roosevelt down Home Avenue because of no stop sign.
- Many car accidents at the entrance/exit of Jewel on Home and at the intersection of Home and Roosevelt. If you run statistics on the intersection accidents, please pull Berwyn's records as well.

Our family wouldn't trade the location of our house for anything, the love for our community, block and house location is strong. My brother/sister in-law, niece and nephew live eleven houses north and the block is like Mardi Gras on Halloween where we have passed out on average 1,500-2,000 pieces of candy each year. This request for The Transportation Commission to implement safer traffic patterns on the 1100 South Block of Home, isn't about that one block, it isn't about making a group of 30 residents happy, it's about the safety of many residents and guests of the Village of Oak Park. For Instance, the following people are at risk due to the speed and frequency cars drive down Home Avenue from I290 to Roosevelt.

- Residents walking down Fillmore to Lincoln School, Carroll Park or Maple Park.



- Non-Residents and Residents walking down Home to the blue line at Garfield Street and Oak Park Avenues.
- Residents walking to the Jewel or to other establishments on Roosevelt.
- Residents and Non-Residents using the pedestrian bridge over I290 on Home Avenue and Garfield Street.
- Everyone driving between Roosevelt and I290 on Home Avenue.

My full trust is in the commission to come up with a solution to this known traffic risk. At the same time I wanted to share with you some of my neighbors' thoughts for a solution to the risk

- Make Home Avenue at Roosevelt a cul-de-sac.
- Make Home Avenue a one way northbound from Roosevelt to Fillmore.
- Make Home Avenue a one way northbound from the alley north of Jewel to Fillmore.
- Place curb bumpouts at the entrance to the alleys north of Roosevelt.
- Place a stop sign north of the alley.
- Put a four way stop sign at Roosevelt and Home.
- Place two speed bumps on each block of Home from Garfield Street to Roosevelt.

I am a resident on the 1150 block of Wisconsin Ave and recently received a notice in the mail to provide comments on possible traffic calming measures to be taken on our and neighboring blocks. I appreciate the opportunity.

We would like the 1150 block of Wisconsin Avenue to be considered for a traffic calming measure. Especially during morning and evening rush hours, there can be quite a bit of traffic on our block and if calming measures are implemented on neighboring blocks, I am concerned that traffic would divert to our block and cause an undue burden. In addition, since the opening of the sports bar on Roosevelt at Wisconsin Ave, our block has seen increased street parking from patrons at the bar. With more cars parked on the street, crossing the street and seeing pedestrians preparing to cross is difficult. Measures to mitigate or better distribute street parking from the bar, or to make pedestrian crossing safer would be beneficial. Lastly, I would submit to the committee that measures to reduce noise pollution from Harlem and Roosevelt traffic would benefit our blocks. Measures such as fences and greater tree coverage may reduce ambient noise from these busy roads.

I am not opposed to the installation of traffic calming devices on the 1150 block of Home. However, the consequences of that installation must also be dealt with. I live on the 1150 block of Wenonah, and for the entire time I have lived here, some 30 years, the alley between Wenonah and Home has been used by non-residents as a shortcut to the Jewel parking lot, despite signs on both ends of the alley saying "No Thru Traffic" and "Do Not Enter". Installing traffic calming devices on Home will most likely increase the use of the alley by non-residents. Other alleys around Oak Park have barriers or calming devices to prevent their use by non-residents.

Installing such devices on the alley between Wenonah and Home in the 1150 block should not be either difficult or summarily dismissed. I raised this issue with the village manager several years ago, and he told me he would look into it. There was no further response or discussion. This alley should be used by residents only and should especially not become a way to avoid traffic calming devices on Home.

Please take this issue into account in your considerations of this issue. If you decide to install traffic calming devices on Home, also restrict the flow of traffic down the alley between Home and Wenonah.

I understand that neighboring residents have petitioned for traffic-calming devices on the 1150 blocks of Home, Wisconsin and Kenilworth. As a resident of the 1100 block of Clinton Ave., I am concerned that negative consequences in the shape of increased (and perhaps more impatient and annoyed) traffic will then route onto our block. Whenever such a measure goes up on one block, it will affect all the surrounding blocks. We should either institute calming measures for all the blocks or perhaps hold off on this for now. If there is an urgent need for such a measure, I would like to know what it is and see that justified for each of the three blocks. That need for each block is not clear. If that need exists and is clear for each of those blocks, then I would like to request that whatever measures are put in place are done so in a way that will not affect the neighboring blocks. As it is, we get quite a bit of traffic, fairly fast some of it, and that is the case for the alley behind our house (on the East side of Carroll park) where thru traffic especially, and parking by the entrance gate continue (the latter has improved but not ceased). (The speed bumps there have been helpful and appreciated but I have wondered about whether increased signage in re blocking thru traffic might also help.)

My husband and I look forward to getting more details on the Village's plans and how any negative impact on surrounding blocks will be mitigated.

I am writing to request that traffic patterns in the neighborhood bounded by Roosevelt, the Eisenhower, Oak Park Avenue and Harlem Avenue be studied for safety considerations before a decision is made to place traffic calming devices on the 1150 blocks of Kenilworth, Home and Wisconsin.

It would be unwise to divert more north-south traffic from these streets onto Clinton Avenue, which is already busy with traffic. Grove is a cul de sac at Roosevelt. Traffic calming devices on three additional north-south streets leaves only Clinton and Maple open to "uncalm" traffic from Roosevelt in the residential neighborhood bounded by Oak Park Avenue and Harlem Avenue.

The 1100 block of Clinton is the block behind Lincoln Elementary School. Many small children cross Clinton daily on their way to and from school at the intersections of Fillmore/Clinton and Harvard/Clinton. The 1100 block of Clinton receives heavier than average traffic related to dropoff and pickup at the school, after-school daycare, school employee traffic, and various activities and events into the early evenings at the school and adjacent Carroll Park.

In addition, Clinton Avenue is very narrow for a two-way street. I believe this is because additional feet of space were given to the block containing the school and park when the neighborhood was first planned. It is not possible for two cars traveling in opposite directions on Clinton to pass each other when faced with parked cars along the street. To drive on our street already requires a lot of dodging in and out of parked cars to allow oncoming traffic to pass.

When I park in front of my house in the late afternoon/early evening, I typically wait for several cars to pass before I can safely open the car door long enough to exit the car without getting hit. I refer to our block as "the racetrack." I believe cars trying to avoid traffic on Harlem and Oak Park Avenue use our street as a short-cut between Roosevelt and the Eisenhower entrance ramp at Harlem. They use our block because Grove is a

cul de sac and to avoid the traffic on Home from cars coming in and out of the parking lot at Roosevelt.

It would make more sense to place a traffic calming device on the 1150 block and 1100 block of Clinton, which drivers appear to view as a clear shot between Roosevelt and Garfield en route to the Eisenhower entrance.

Or, maybe 1100 Clinton should be made a one-way street, like 1100 Grove, the street on which Lincoln School is located. Another possibility would be a traffic calming device in the 900 block of Clinton. Fillmore is also heavily traveled and might benefit from a traffic calming device at Oak Park Avenue.

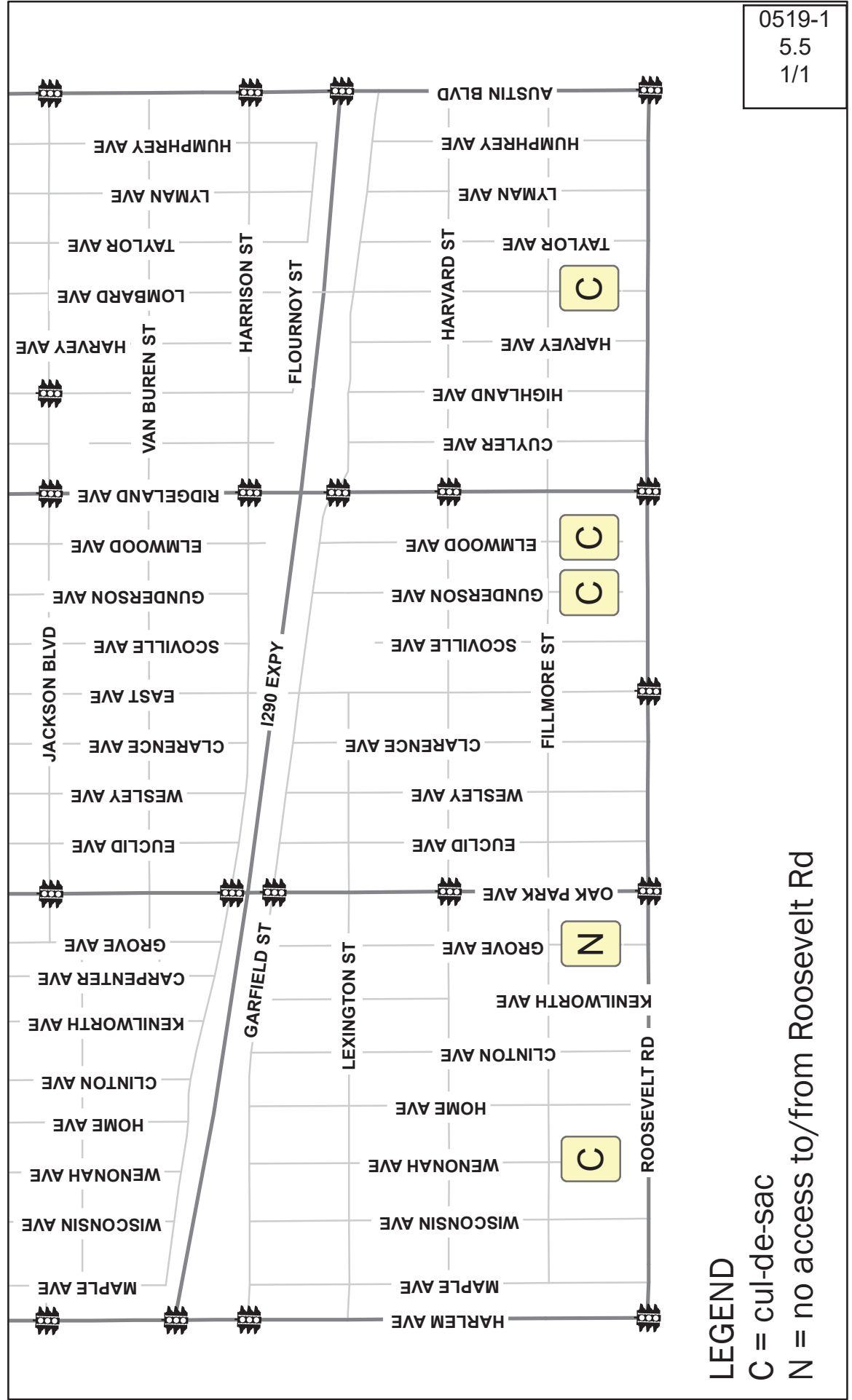

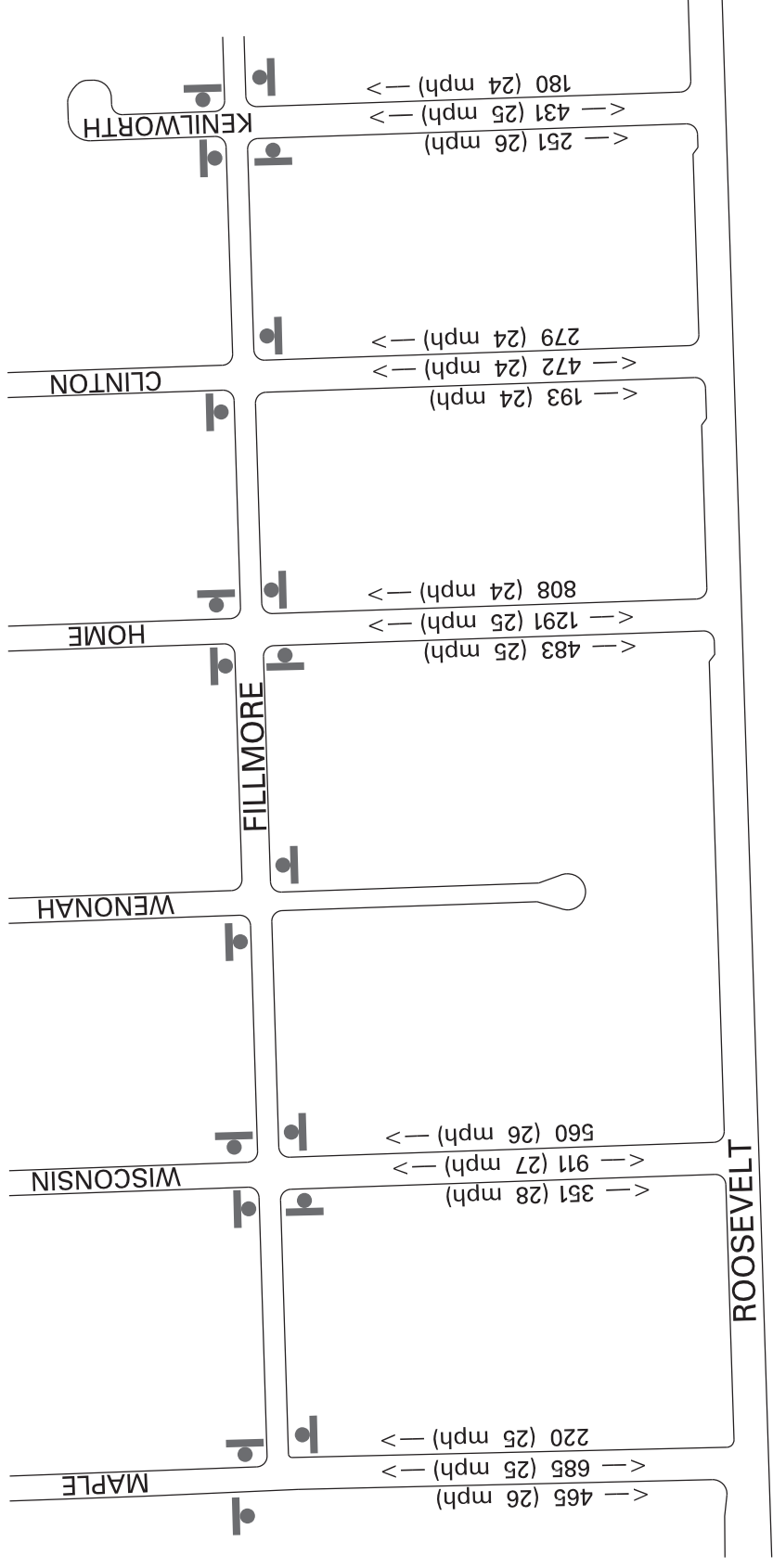
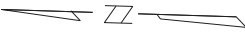

# Existing Cul-de-Sacs and No Access to Roosevelt Road on the 1150 Blocks in the Village of Oak Park as of March 2019





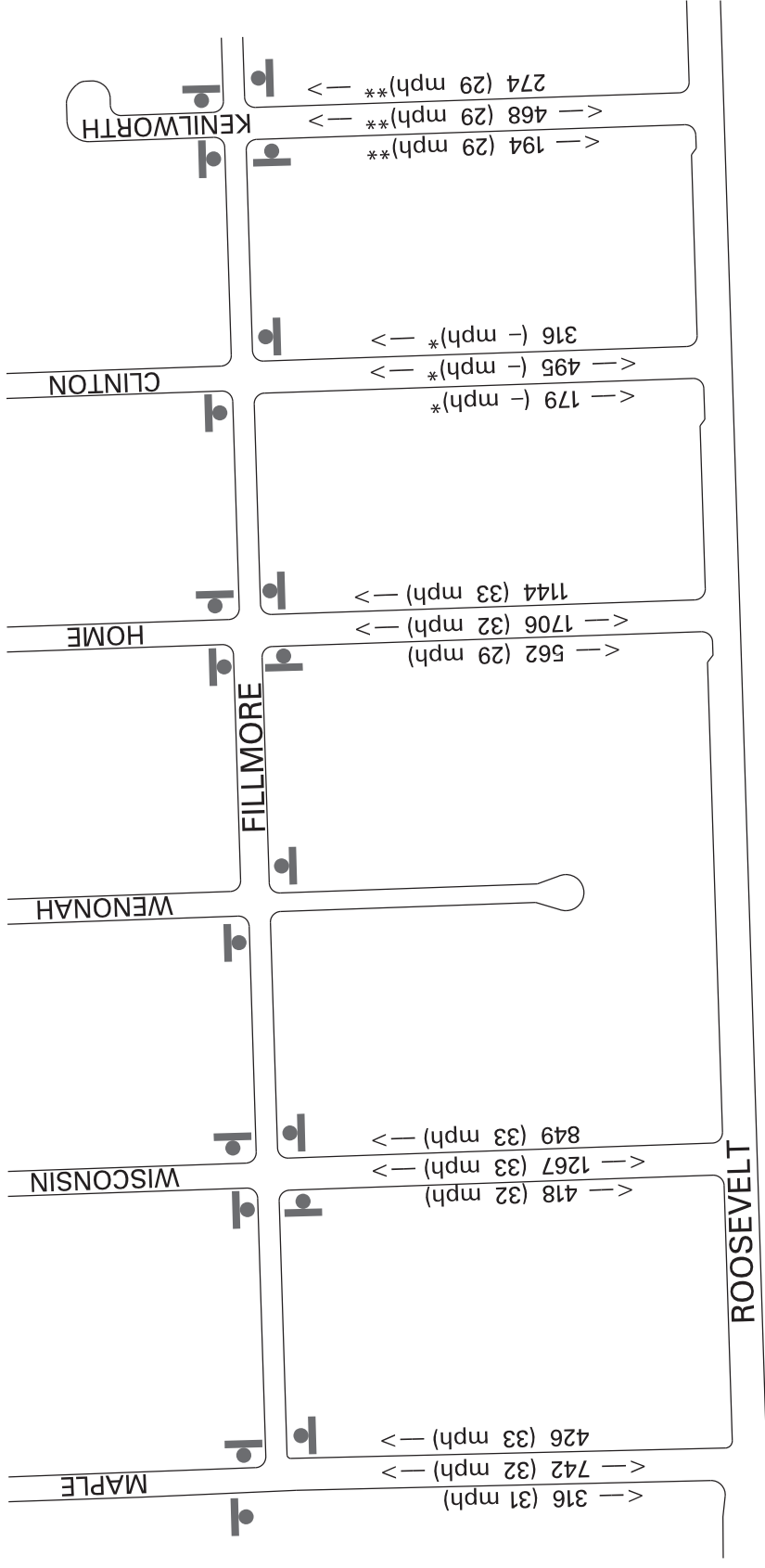

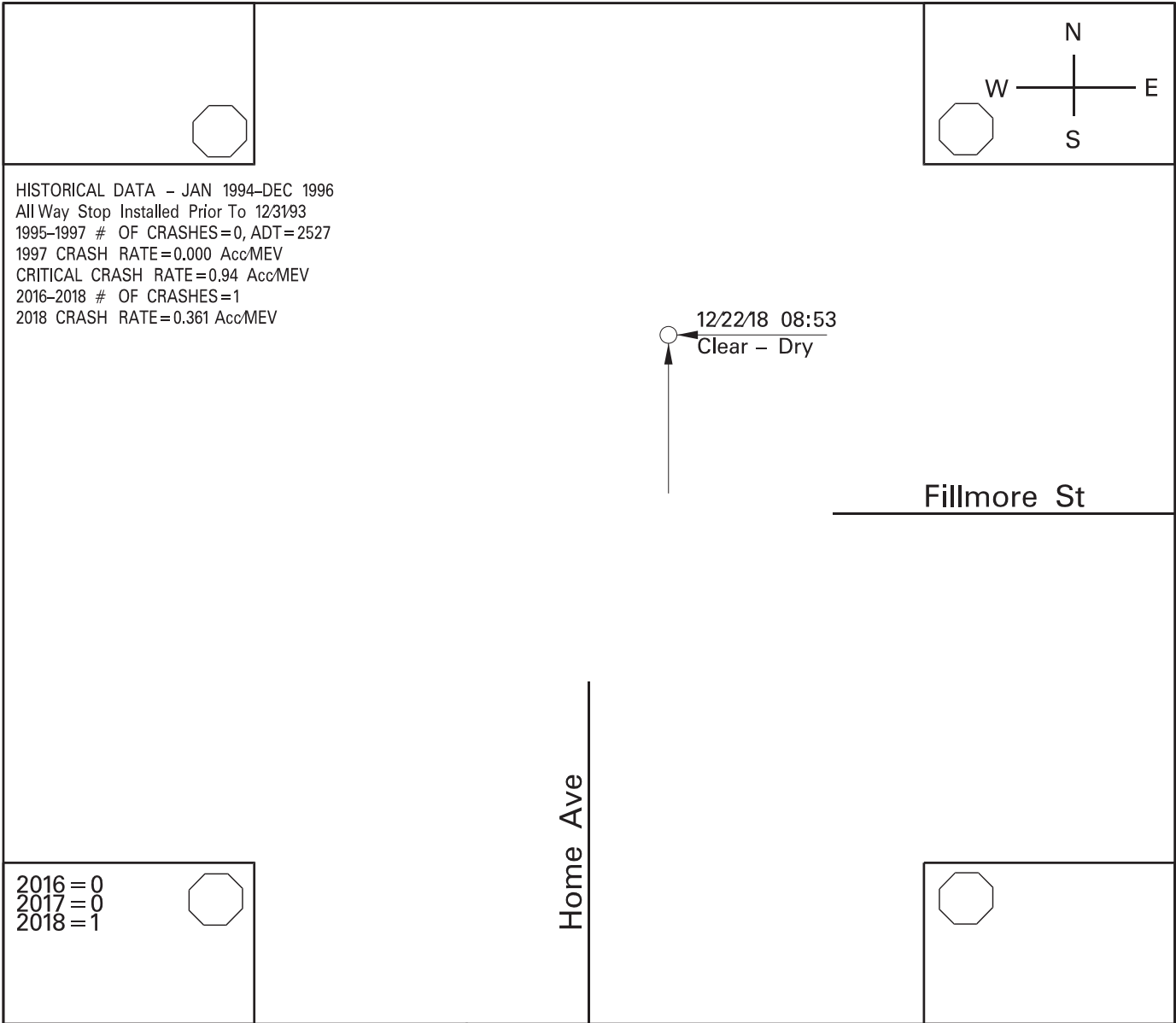

# VILLAGE OF OAK PARK COLLISION DIAGRAM

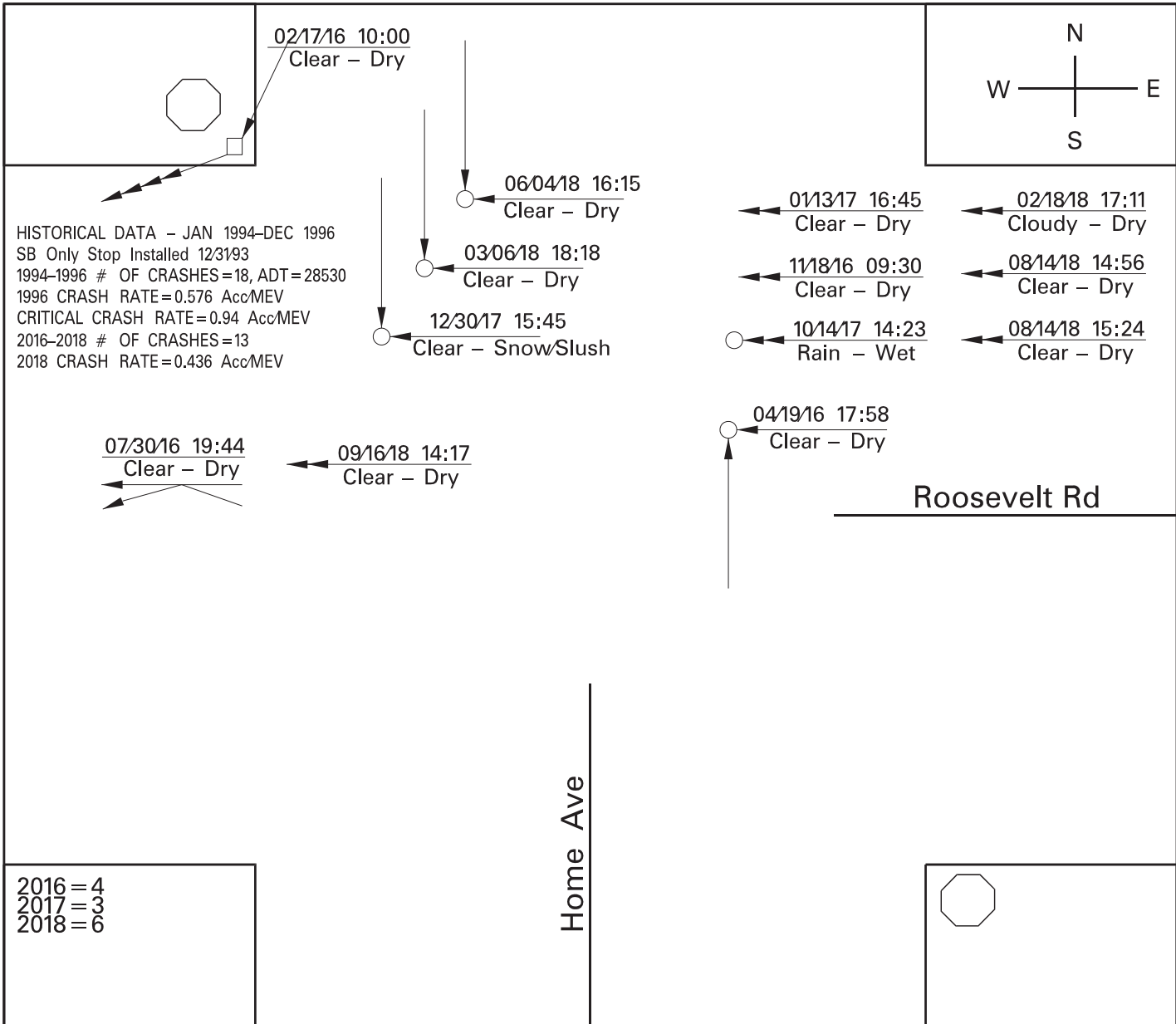

The Village of Oak Park has received a valid petition requesting a traffic calming device on the 1150 block of Home Ave. The petition will be reviewed by the Transportation Commission in the coming months to determine if traffic calming is recommended and which type of calming may be most appropriate. The Transportation Commission's recommendation would likely be brought before the Village Board of Trustees for final action.

Traffic calming is a term used to describe physical improvements or other measures meant to improve safety and encourage more responsible driving by potentially reducing the speed or volume of vehicles. A table showing approved traffic calming treatments and how they would be funded is included on the back of this letter.

The Village prefers to look at the issue of traffic calming in the southwest section of the Village in a holistic manner. Your block is one of the blocks between Harlem Ave and Oak Park Ave that does not have some type of traffic calming device. Village staff is reaching out to you and your neighbors to inform you of the traffic calming petition from the 1150 block of Home Ave. If you feel that your block should also be considered for traffic calming improvements; the Village encourages you to submit a traffic calming petition so all the blocks can be considered in a holistic manner and any recommendations for improvements are uniform and consider the needs of all blocks.

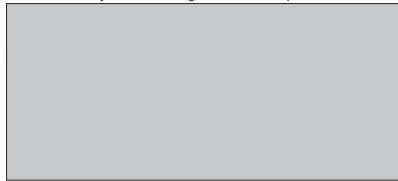
Several decades ago, street parking on the 1150 S. Elmwood block was difficult. This was due to several factors. These included the fact that there was a car dealership on the corner of Roosevelt which used to park their cars on Elmwood during the day, the fact that Turano Bakery was a smaller bakery, with little to no employee parking, and the fact that patrons of other businesses on Roosevelt would also park on the street. Many of these factors have been mitigated over time. The car dealership is gone, Turano now has three employee lots, and the bakery has taken over much of Roosevelt road. Additionally, with the creation of the cul de sac at the end of the block, it is no longer convenient to park and walk from Elmwood to businesses on Roosevelt Road.

Having resident permit parking only during the weekdays has become a burden for many of the families on the block. Some are visited by caregivers or family, and need to ensure that visitors passes are on hand. Other homes with young families already pay \$101 to have Illinois plate registration and \$70 for the Village stickers per car. An additional \$74/year for the convenience of parking in front of one's house to unload groceries or between running shorter errands seems excessive.

For these reasons, we would like the resident permit parking only zone lifted from our block.
