# DRAFT Meeting Minutes Transportation Commission Monday, December 16, 2019 – 7:00 p.m. Council Chambers – Village Hall

#### 1. Call to Order

Chair Ron Burke called the meeting to order at 7:05 PM.

#### Roll Call

#### 2. Non-Agenda Public Comment

Doug Chien, a resident of the 1000 block of Highland, spoke about his daughter attending Julian middle school and would like to request No Turn on Red signs and timed, signalized phases at some intersections for pedestrians.

Michelle Gurgas, also a resident of the 1000 block of Highland, supports Doug Chien's requests and would like them to be added to the Commission's work plan.

Commissioner Taylor spoke about evaluating safe routes to schools and Mike Koperniak, Public Works Civil Engineer/Transportation Commission Staff Liaison, responded the Village is already scheduled to work with Julian to revise their safe routes to school maps in the spring of 2020.

The floor was closed to public comment.

3. Commissioner Thompson made a motion to approve the agenda as presented which was seconded by Commissioner Katner. The motion was approved by a unanimous voice vote.

#### 4. Approval of Draft Transportation Commission Meeting Minutes

Commissioner Thompson made a motion to approve the draft October 28, 2019 Transportation Commission meeting minutes as presented which was seconded by Commissioner Fink. The motion was approved by a unanimous voice vote.

5. <u>REVIEW FEASIBILITY OF REPLACING THREE PARKING SPACES ON THE EAST SIDE OF EUCLID AVENUE NORTH OF LAKE STREET WITH A NO PARKING ANY TIME ZONE</u>

Public Works Civil Engineer/Transportation Commission Staff Liaison Mike Kopernial gave a presentation on staff's recommendation and background information of replacing three parking spaces on the east side of Euclid Avenue north of Lake Street with a no parking any time zone. The presentation included before and after condition sketches of the north leg of Euclid Avenue at Lake Street as well as daytime and night time photographs of Euclid Avenue.

Mike Koperniak read public testimony that was sent in to the Village via email.

The Commission asked questions regarding if this was a staff-initiated request, what parking was like before the construction of District House, and if there was any discussion about parking when the building was in the Plan Commission. There were further questions about parking for the garage at District House, where the rest of the Y1 zone is and if there would be only one Y1 zone space on the block, if any thought was given to the confusion of having only one space on the block and what the daytime parking availability in the area is.

The floor was opened to public testimony.

Bruce Brigell, a resident of the 100 block of North Euclid Avenue, is in favor of the removal of the spaces but suggested maintaining four spaces to the north during the day for caretakers and the elderly who reside in the Mews of Oak Park condominium building.

Paula O'Connor, a resident of the 100 block of North Euclid Avenue, is in favor to remove the three spaces due to the congestion of traffic on the block. She stated the street is very narrow already and feels with increased traffic it is a hazard and an accident waiting to happen. Ms. O'Connor is in favor of removing all parking on one side of the street to help with traffic and leaf collection. She also spoke of her observations of drivers turning around in her and her neighbor's driveways and the entrances of the building which is also causing hazards.

Kevin Friker, a resident of the 100 block of North Euclid Avenue, is in favor of removing the spaces and stated the intersection is very narrow and removing the spaces would relieve traffic. He notices how many people use Euclid Avenue as a cut through to avoid the Oak Park Avenue and Lake Street intersection but thinks the police should monitor the street.

Linda Haley, a resident of the 100 block of North Euclid Avenue, supports removing the spaces and spoke about witnessing drivers turning around in the District House driveway. Ms. Haley has additional concerns regarding illegal parking and that cars parking on both sides of the block narrows the street. Ms. Haley also spoke about cars parking on Euclid Avenue directly across from the District House driveway making it difficult for their residents to pull out onto the street and thinks more enforcement would help.

Leslie Denstaedt, a resident of the 100 block of N Euclid Avenue, spoke of previously requesting the 100 block of north Euclid Avenue to be made resident only parking and it

was turned into three hour parking. Ms. Denstaedt has noticed more parking on the block in recent years and knows people are not paying to park there. She said with the addition of the District House condo building and the Fair Grounds Coffee & Tea Shobusiness, traffic has increased causing a hazard with speeding cars and kids on bikes in the area. Ms. Denstaedt believes removing the three parking spaces will be a hardship on the residents of the building and suggests moving the three spaces down the block.

Michelle Wheeler, a resident of District House, spoke about problems with cars parking on the block and the additional traffic due to the businesses. She agrees the spaces should be removed but would like to see the three spaces on the west side of the street removed as well. Ms. Wheeler thinks if spaces were removed on both sides of the block it would make a much wider street and thinks it should be parking on only one side of the street.

Wendy Greenhouse, a resident of District House, agrees that the three spaces need to be removed. Ms. Greenhouse spoke of the need for short term parking in the area for the businesses because many people do not want to park in Avenue garage and walk over. She spoke of the busy activity in and out of their garage, drivers using their apron for a turn around, and the difficulties of pulling out of the garage and not being able to see oncoming traffic. Ms. Greenhouse spoke of the dangers due to no alley access and observations of trucks using Euclid Avenue as a cut through. She thinks there should be a way to stop drivers from cutting through, maybe with a speed bump.

The floor was closed to public testimony.

Chair Burke spoke about prioritizing Downtown Oak Park to be a safe, inviting place for pedestrians and cars and talked about the density of the Village.

#### The Commission discussed:

- The parking situation on Lake Street metered and short term parking east of Euclid Avenue.
- Possibly changing two hour parking east of Euclid Avenue on Lake Street from two hours to one hour for more turnovers.
- Enforcement of parking.
- Free parking on Lake Street as opposed to paid for parking in garages.
- Pushing the three spots to the north for Y1 zone parking at night and one hour spots during the day.
- Looking at parking on the 100 block of North Euclid Avenue north of The Mews condo building and possibly having no parking at all on one side of the street.
- Parking for caregivers.
- Alternate parking options and/or restrictions for Euclid Avenue and Lake Street.
- Safety issues versus parking issue.

Commissioner Taylor made recommendations (1) for staff to replace three parking spaces on the east side of Euclid Avenue north of Lake Street with a No Parking Any Time zone, (2) evaluate additional one hour parking on Euclid Avenue north of the

Mews condo building, and (3) evaluate additional metered parking on Lake Street e of Euclid Avenue. The motion was seconded by Commissioner Katner.

Public Works Civil Engineer/Transportation Commission Staff Liaison Mike Koperniak gave an update to the Commission on evaluating four key intersections for pedestrian safety. Mike spoke about the background information on the four intersections and spoke about updated crash reports and included imagery of all legs of the four intersections.

Chair Burke asked about the crash information for the intersections.

Mike continued the presentation with information on planned intersection upgrade at Lake Street and Scoville Avenue in 2020.

The Commission discussed the information provided to them.

Abstract (briefly describe the item being reviewed):					
Back in November 2005 staff presentation demonstrated a need and review of the overnight Z3 area expanded to include 400-416 N Taylor Ave. After general discussion and Board approval this was added to the Overnight Z3 parking area.					
Last year village staff received a petition to include overnight Z3 parking at 428 and 430 N Taylor Ave. This area falls within the guidelines of Village Ordinance 2005-0-22, which allows for the establishment of overnight on-street permit parking within 500 feet from a commercial district that is adjacent to an R-7 residential area. This will add an additional four overnight parking spaces in the Z3 overnight on-street permit parking area.					
Staff Recommendation(s):					
Approve the petition and add additional spaces at Z3 overnight on-street permit parking at the frontage of 428 and 430 N Taylor Ave which falls directly within an R-7 zoned area district.

I am writing in hopes that the village will consider adding additional parking to the Z3 parking permit zone as it is currently full and the lack of parking makes it hard for the residents of the building at 59-61 Chicago Ave/426-430 N. Taylor. As the leasing agent & a resident of the building, I have had issues finding parking in my zone as a permit holder & we also have issues when trying to rent other units in the building as the current zone is full which leaves no overnight parking options in the area unless you can secure a private space. How can owners rent apartments when no parking can be found? We live in a time when everyone has cars, even if they use public transportation. More parking is needed in Oak Park in general but increased parking in this zone is needed as more people move into the area.

We are asking that the Z3 zone be expanded as there are open streets in the area that could add more permit spots. Including in front of our building 426-430 N. Taylor. I have attached the zone map and highlighted other areas which are not in front of single family homes and could expand the parking permit area and allow for more residents to have night parking when nothing else is available.



# On-street Permit Sales

Zone Z3

Vehicles displaying a valid on-street overnight permit may park in the permit zone designated by the permit. Park only in areas designated by posted signs. A zone permit does not authorize parking in a lot.


Generally, zone permits are valid from 11 p.m. to 6 a.m., seven days per week. However, times may vary by zone. Specific permit hours are posted on street signs within the zones. Zone permits do not override other posted parking restrictions, such as for street maintenance, time of day limitations and time limits.

#### **New Permit Purchase**

Permits are sold quarterly: February – April, May – July, August – October and November – January. The fee may be prorated if the permit is purchased after the beginning of a quarter. Proof of residency and vehicle owner information is required to purchase a zone permit. Vehicles must display license plates with a valid vehicle state registration sticker, as well as a current Oak Park vehicle sticker. All unpaid parking citations and fines due the Village must be paid in full to purchase a permit. Only one permit may be purchased per household.

#### **Permit Renewals**

Renewals must be made prior to the deadline. Renewal letters are sent as a courtesy reminder, but do not guarantee a new permit. Permits may be renewed three weeks prior to the start of each quarter. Renew on-line, by mail or at Village Hall, 123 Madison St., either in person or via a drop box by



week. Payment may be made by cash, check or credit card. Mail renewals should be made by check or credit card. Do not mail cash. Online renewals require a credit card. Deadlines for renewal via mail and online are approximately six business days prior to quarter's end. All unpaid parking citations and other fines must be paid in

#### **Where to Place Permit**

full to renew a permit.

Affix the permit to the outside of the rear window on the driver's side, in the lower corner. A vehicle with no rear window, such as a convertible, should display the permit on the front window, driver's side. Remove expired parking permits and vehicle stickers. Clean window and allow it to dry thoroughly. Remove backing and fully attach permit to the window, making sure the information is not obstructed from view.

#### Permit Transfer or Reissue

Zone permits are not transferable unless authorized by the Village. Report any change in vehicle, vehicle owner, address or license plate information. Providing false or inaccurate information, or failing to notify the Village of changes in information, may result in loss of parking privileges. A \$5 administrative fee is charged to replace a permit that is lost or transferred

to another vehicle.

#### Refunds

A permit holder who is moving or no longer in need of a permit may be eligible for a prorated refund. Peel off the decal and return it to Village Hall to apply. If approved, refunds are pro-rated for the remainder of the quarter.

#### Restrictions

The Village may revoke or cancel any permit issued for a vehicle that is too large to park within a single parking space without parking on the curb or protruding into the driving lane. Vehicles cannot be covered.

The Village of Oak Park received a petition to expand the current overnight on-street permit parking zone Z3 to include 426-430 N Taylor Zone Z3 currently includes the <u>700 portions of Chicago Ave between Humphrey and Ridgeland Ave, 427-449 block of North Lombard Avenue, and 408-412 North Taylor Avenue.</u>

Based upon an evaluation of the area and the current Village policies governing the establishment of overnight on-street permit parking, the proposed area qualifies for overnight permit parking. If recommended by the, Transportation Commission and approved by Village Board, this will add approximately four (4) additional overnight permit parking spaces to zone Z3.

#### Abstract (briefly describe the item being reviewed):

On October 17, 2018, the Village of Oak Park received a petition to install a traffic calming device on the 1150 block of Home Avenue. Resident concerns include: vehicle crashes, dangerous driving, motorists speeding on the block when Roosevelt Road is congested and construction of a Montessori school at the northeast corner of Home Avenue and Roosevelt Road which will increase traffic on the block.

At its May 30, 2019 meeting, the Transportation Commission tabled the item until a traffic study could be completed which includes traffic from Alcuin Montessori School that was being constructed at the intersection of Home Avenue and Roosevelt Road.

On August 21, 2019, the Village of Oak Park received a petition to install a traffic calming device on the 1150 block of Clinton Avenue. Resident concerns include: vehicles using the block to bypass congested Roosevelt Road, vehicles driving too fast on the block and heavy volumes of traffic. Clinton Avenue is a narrow street with vehicles parked on both sides making it impossible for vehicles traveling in opposite directions to pass one another. With Alcuin Montessori School to be opened in the fall, the situation will only deteriorate.

At tonight's meeting, staff will present the collected traffic data, and public testimony will be taken. The Transportation Commission may concur with staff's recommendation or make a different recommendation.

#### Staff Recommendation(s):

Staff is recommending to implement portable speed radar signs or speed wagons on an intermittent basis only to maintain vehicle speeds at or near the posted speed limit.

On May 30, 2019, the Transportation Commission reviewed the petition from the 1150 block of Home Avenue. At that time, the Commission tabled the item until staff is able to collect additional traffic data which will include Alcuin Montessori School that was being built at the northeast corner of Home Avenue and Roosevelt Road. Construction was completed in the summer however not all programs were operating until late fall.

#### Petition Submittal for the 1150 Block of Home Avenue

On October 17, 2018, the Village of Oak Park received a petition to install a traffic calming device on the 1150 block of Home Avenue. Residents representing 84.03% of the street frontage on the petitioning block signed the petition. The petition was certified as a valid petition.

Reasons provided for the petition include: vehicle crashes, dangerous driving, motorists speeding on the block when Roosevelt Road is congested and construction of a Montessori school at the northeast corner of Home Avenue and Roosevelt Road which will increase traffic on the block. A second submitted letter of explanation talks of the narrow roadway width of Home Avenue, congestion on the block due to vehicles having to wait for oncoming traffic to proceed, speeding vehicles, and the many crashes on Home Avenue at the Jewel exit and at Roosevelt Road. See Exhibit 6.2, pages 1-5 for a copy of this petition and accompanying letters of explanation.

On May 15, 2019 the Village of Oak Park sent a notification letter to the residents on the 1150 blocks of South Maple Avenue, Wisconsin Avenue, Clinton Avenue and Kenilworth Avenue that the Village received a valid petition requesting a traffic calming device on the 1150 block of Home Avenue. Further, the Village would prefer to look at the issue in a holistic manner on the 1150 blocks in the southwest section of the Village. Their blocks are the other 1150 blocks between Harlem Avenue and Oak Park Avenue without some type of calming device. And if they feel their block should be considered they can submit a petition as well (see Exhibit 6.8 for the notification letter).

As a result of the letter, residents from the 1150 block of Wisconsin Avenue and the 1150 block of South Kenilworth Avenue contacted the Village to obtain a traffic calming petition for their blocks.

Ultimately, the Village did not receive a signed traffic calming petition from either of those blocks. Rather the Village received a traffic calming petition from the 1150 block of Clinton Avenue in the intervening months. Therefore, the traffic calming petitions from the 1150 blocks of Home and Clinton Avenues are being considered at tonight's Transportation Commission meeting.

#### Petition Submittal for the 1150 Block of Clinton Avenue

On August 21, 2019, the Village of Oak Park received a petition to install a traffic calming device on the 1150 block of Clinton Avenue. Residents representing 68.31% of the street frontage on the petitioning block signed the petition. The petition was certified as a valid petition.

Reasons provided for the petition include: vehicles using the block to bypass congested Roosevelt Road, vehicles driving too fast on the block and heavy volumes of traffic. Clinton Avenue is narrow street with vehicles parked on both sides making it impossible for vehicles traveling in opposite directions to pass one another. There are 20 children living on the block with nine of them being under the age of 5 years old. With Alcuin Montessori School to be opened in the fall, the situation will only deteriorate. The school is set up to direct exiting traffic to this block. See Exhibit 6.2, pages 6-12 for a copy of this petition and accompanying letters of explanation.

See Exhibit 6.3 for written public testimony received by the Village of Oak Park regarding these petitions. There is 1 email opposed to the petitions unless there is crash history to support a traffic calming device, 4 emails in support of a traffic calming measure on the Clinton block, and 4 emails that are neutral to the petitions but comment that other blocks should be included in this traffic calming discussion or mention other issues that should be addressed.

A directional twenty-four hour traffic volume and speed study was conducted on Thursday, May 2, 2019 for the 1150 blocks of South Maple, Wisconsin, Home, Clinton, and South Kenilworth Avenues. A second directional twenty-four hour traffic volume and speed study was conducted on Thursday, December 5, 2019 for these same blocks. See Exhibit 6.6 pages 1-2 for a summary of the results. Source data for the December 2019 data collection is also included in Exhibit 6.6 pages 4-18. Source data for the May 2019 data collection is included in the agenda for the May 30, 2019 Transportation Commission meeting (see Exhibit 5.6 pages 3-17 of the May 30, 2019 agenda). Similar data was collected in 2002 & 2003 for the same blocks. A summary of the 2002 & 2003 data is also provided for historical comparison (see Exhibit 6.6 page 3).

Collision diagrams for the intersections of Home Avenue & Fillmore Street, Home Avenue & Roosevelt Road, Clinton Avenue & Fillmore Street, and Clinton Avenue & Roosevelt Road were generated. See Exhibit 6.7 for the four collision diagrams.

Next, staff completed a scoring table for both traffic calming petitions. See Exhibit 6.4 for the scoring tables. A numerical score is calculated for six measures that are the typical

reasons for a petition to be submitted. The maximum possible score is 100 points. A minimum score of 25 points is required to bring a petition before the Transportation Commission.

The updated total score for the 1150 block of Home Avenue petition is 53 points. The total score for the 1150 block of Clinton Avenue petition is 37 points. Scores for both petitions exceed the minimum score necessary to submit the petition to the Transportation Commission for review and recommendation.

See Exhibit 6.5 for the blocks with existing cul-de-sacs, no access or limited access to Roosevelt Road between Harlem Avenue and Austin Boulevard. This exhibit shows the traffic limiting measures that have been employed along Roosevelt Road.

Reviewing the 24-hour volumes for all five blocks studied in May and December 2019 (Exhibit 6.6), the two-way average daily traffic (ADT) ranged from a low of 431 vehicles on 1150 block of South Kenilworth Avenue in May 2019 to a high of 1,407 vehicles on 1150 block of Home Avenue in December 2019. The 2019 volumes for all blocks but the 1150 block of Home Avenue fall within or below the 800 to 1,200 vehicle range for typical daily volume on residential streets within the Village of Oak Park.

The 1150 block of Home Avenue volume is 7.5% and 17.5% higher than upper volume limit for a typical residential block in the Village from the May 2019 and December 2019 traffic studies, respectively. This can be partially explained by the fact the Jewel grocery store is located at the northwest corner and Alcuin Montessori School is at the northeast corner of the Home Avenue and Roosevelt Road intersection. Both entities are trip generators. It should also be noted the 1150 block of Home Avenue is classified as a collector street according to the Village's Comprehensive Plan. So the 1150 block of Home Avenue is expected to service higher volumes of traffic on the block than the adjacent blocks which are classified as residential.

Regarding vehicular speeds, it is an accepted traffic engineering practice to set the speed limit to the 5 mile per hour (mph) increment above or below the 85th percentile speed. Village Staff holds the opinion that the majority of drivers will drive at or near the posted speed limit. In addition, it is an accepted fact that the speed indicated on speedometers can vary up to 2 percent above or below the actual speed of the vehicle.

By definition, the 85th percentile speed is the speed at which 85 percent of the vehicles are traveling at or less than. Conversely, 15 percent of the vehicles will be traveling faster than the 85th percentile speed. It has already been stated that speed limits are typically set to the 5 mph increment above or below the 85th percentile speed. This implies that it is expected that approximately 15 percent of vehicles will be traveling faster than the speed limit, if the speed limit is in the 5 mph increment below the 85th percentile speed.

Next is the review of both the May and December 2019 traffic studies results regarding vehicle speeds on the 1150 blocks of South Maple, Wisconsin, Home, Clinton, and South

Kenilworth Avenue. The 85th percentile speeds for all blocks in both 2019 traffic studies ranged between 24 mph and 29 mph. In the May 2019 traffic study, all blocks but the 1150 block of Wisconsin Avenue had 85th percentile speeds that were at or below the 25 mph speed limit for two-way traffic. The 85th percentile speeds for the same blocks were marginally higher on the December 2019 traffic study than that of the May 2019 traffic study. The 1150 blocks of Home and Clinton Avenues had 85th percentile speeds that were slightly above the speed limit. As previously mentioned, it's expected that the majority of motorists will drive at or close to the speed limit and that speeds indicated on speedometers can vary above or below the actual speed of the vehicle. Consequently, the 85th percentile speeds calculated in the two 2019 traffic studies for the petitioning blocks is what staff would consider within the range of the speed limit.

Based on the two traffic studies conducted in 2019, there does not appear to be a speeding problem on the 1150 blocks of Home and Clinton Avenues.

Next, thirty-six months of vehicle crash reports covering the period of January 2017 through December 2019 were reviewed for the 1150 blocks of Home and Clinton Avenues. Please see Exhibit 6.7 for the four collision diagrams.

The number of reported crashes that occurred at the Home Avenue and Fillmore Street intersection for the thirty-six months ended December 31, 2019 totaled one. It was a right angle collision in 2018. The average daily traffic for the intersection as determined as part of the Village's 1998 area-wide traffic study was 2,527 vehicles. From this data, the 2019 crash rate for the Fillmore Street and Home Avenue intersection is calculated to be 0.361 accidents per million entering vehicles (Acc/MEV).

This crash rate is below the critical crash rate calculated for this section of the Village (south of the Eisenhower Expressway between Harlem Avenue and Austin Boulevard) as determined in the area-wide traffic study of 1998 (0.94 Acc/MEV). If an actual crash rate exceeds the critical crash rate then it is highly probable that the accidents were caused by factors other than chance.

The number of reported crashes that occurred at the intersection of Home Avenue and Roosevelt Road for the same time period totaled fourteen crashes. The average daily traffic for the Home Avenue and Roosevelt Road intersection as determined as part of the 1998 traffic study was 28,530 vehicles. The 2019 crash rate for this intersection is calculated to be 0.448 Acc/MEV which is also lower than the critical crash rate of 0.94 Acc/MEV.

The number of reported crashes that occurred at the Clinton Avenue and Fillmore Street intersection for the thirty-six months ended December 31, 2019 totaled five. Four crashes were vehicles that struck parked cars (two on Clinton Avenue and two on Fillmore Street). The one remaining crash was a right angle collision in 2019. The average daily traffic for the intersection as determined as part of the Village's 1998 area-wide traffic study was 2,219 vehicles. From this data, the 2019 crash rate for the Fillmore Street and Home Avenue intersection is calculated to be 2.058 accidents per million entering vehicles (Acc/MEV).

As mentioned previously, four of the crashes were vehicles striking parked cars. These crashes cannot be corrected by a traffic control device whereas the right angle collision could be corrected. Therefore the 2019 correctible crash rate for Clinton Avenue and Fillmore Street is 0.412 Acc/MEV which is lower than the critical crash rate of 0.94 Acc/MEV.

The number of reported crashes that occurred at the intersection of Clinton Avenue and Roosevelt Road for the same time period totaled four crashes. The average daily traffic for the Home Avenue and Roosevelt Road intersection as determined as part of the 1998 traffic study was 28,034 vehicles. The 2019 crash rate for this intersection is calculated to be 0.130 Acc/MEV which is also lower than the critical crash rate of 0.94 Acc/MEV.

In conclusion, there does not seem to be a problem with vehicle crashes on the 1150 blocks of Home and Clinton Avenues.

Based on the traffic studies conducted and the crash history for the 1150 blocks of Home Avenue and Clinton Avenue, it appears there are no traffic issues such as vehicle volumes, speeds or crashes. Staff recommends to implement portable speed radar signs or speed wagons on an intermittent basis only to maintain vehicle speeds at or near the posted speed limit.

To: Oak Park Transportation Commission

Residents of twenty two (22) houses on the 1150 block of South Clinton have signed a petition requesting traffic calming devices on our block. We would like to have either a cul-de-sac or a one-way street going south with a narrowing of the street just north of the east-west alley to allow passage of just one car at a time.

Our block currently has heavy traffic from vehicles trying to avoid congestion on Roosevelt Road. The drivers, upset from being stuck in that traffic, drive much too fast on a street that is home to twenty (20) children including nine (9) under 5 years old. This traffic includes the daily passage of large, commercial trucks.

South Clinton is a narrow street and with vehicles, often large SUVs, parked on both insides it is impossible for vehicles traveling in opposite directions to pass each other. These parked vehicles also make it difficult for drivers speeding north on the street to see the children.

With the opening of the Alcuin Montessori School at the south end of block this September the situation will only deteriorate. Residents of that end of the block already cannot park in front of their homes. Driving east on Roosevelt at 4 pm recently, I saw a school bus waiting in front of the school. I am writing to urge the Commission to convert our block, the 1150 block of Clinton Avenue, into a one-way street facing South (opening onto Roosevelt Road). We have an unusually large number of children on the block (20), including nine children under the age of 5. In recent months, the traffic roaring up our street (headed north) has sharply increased, as has the SIZE of those vehicles. A majority drive much too fast for conditions, and they do NOT slow down for children. They can't even see the children, as people working in nearby businesses and visiting the bars and school now park in every available slot on the block, so the children have to walk between parked cars in order to cross the street. As a result, I and other residents here fear for our children's safety. It's also become extremely difficult to drive in two directions, as Clinton Avenue is a narrow street and the vehicles coming from the alley and Roosevelt Road are often QUITE large and wide — and FAST. I am a resident on the 1150 block of Wisconsin Ave and recently received a notice in the mail to provide comments on possible traffic calming measures to be taken on our and neighboring blocks. I appreciate the opportunity.

We would like the 1150 block of Wisconsin Avenue to be considered for a traffic calming measure. Especially during morning and evening rush hours, there can be quite a bit of traffic on our block and if calming measures are implemented on neighboring blocks, I am concerned that traffic would divert to our block and cause an undue burden. In addition, since the opening of the sports bar on Roosevelt at Wisconsin Ave, our block has seen increased street parking from patrons at the bar. With more cars parked on the street, crossing the street and seeing pedestrians preparing to cross is difficult. I am not opposed to the installation of traffic calming devices on the 1150 block of Home. However, the consequences of that installation must also be dealt with. I live on the 1150 block of Wenonah, and for the entire time I have lived here, some 30 years, the alley between Wenonah and Home has been used by non-residents as a shortcut to the Jewel parking lot, despite signs on both ends of the alley saying "No Thru Traffic" and "Do Not Enter". Installing traffic calming devices on Home will most likely increase the use of the alley by non-residents. Other alleys around Oak Park have barriers or calming devices to prevent their use by non-residents.

Installing such devices on the alley between Wenonah and Home in the 1150 block should not be either difficult or summarily dismissed. I understand that neighboring residents have petitioned for traffic-calming devices on the 1150 blocks of Home, Wisconsin and Kenilworth. As a resident of the 1100 block of Clinton Ave., I am concerned that negative consequences in the shape of increased (and perhaps more impatient and annoyed) traffic will then route onto our block. Whenever such a measure goes up on one block, it will affect all the surrounding blocks. We should either institute calming measures for all the blocks or perhaps hold off on this for now. If there is an urgent need for such a measure, I would like to know what it is and see that justified for each of the three blocks. That need for each block is not clear. If that need exists and is clear for each of those blocks, then I would like to request that whatever measures are put in place are done so in a way that will not affect the neighboring blocks. As it is, we get quite a bit of traffic, fairly fast some of it, and that is the case for the alley behind our house (on the East side of Carroll park) where thru traffic especially, and parking by the entrance gate continue (the latter has improved but not ceased). (The speed bumps there have been helpful and appreciated but I have wondered about whether increased signage in re blocking thru traffic might also help.)

I am writing to request that traffic patterns in the neighborhood bounded by Roosevelt, the Eisenhower, Oak Park Avenue and Harlem Avenue be studied for safety considerations before a decision is made to place traffic calming devices on the 1150 blocks of Kenilworth, Home and Wisconsin.

It would be unwise to divert more north-south traffic from these streets onto Clinton Avenue, which is already busy with traffic. Grove is a cul de sac at Roosevelt. Traffic calming devices on three additional north-south streets leaves only Clinton and Maple open to "uncalm" traffic from Roosevelt in the residential neighborhood bounded by Oak Park Avenue and Harlem Avenue.

The 1100 block of Clinton is the block behind Lincoln Elementary School. Many small children cross Clinton daily on their way to and from school at the intersections of Fillmore/Clinton and Harvard/Clinton. The 1100 block of Clinton receives heavier than average traffic related to dropoff and pickup at the school, after-school daycare, school employee traffic, and various activities and events into the early evenings at the school and adjacent Carroll Park.

In addition, Clinton Avenue is very narrow for a two-way street. I believe this is because additional feet of space were given to the block containing the school and park when the neighborhood was first planned. It is not possible for two cars traveling in opposite directions on Clinton to pass each other when faced with parked cars along the street. To drive on our street already requires a lot of dodging in and out of parked cars to allow oncoming traffic to pass.

When I park in front of my house in the late afternoon/early evening, I typically wait for several cars to pass before I can safely open the car door long enough to exit the car without getting hit. I refer to our block as "the racetrack." I believe cars trying to avoid traffic on Harlem and Oak Park Avenue use our street as a short-cut between Roosevelt and the Eisenhower entrance ramp at Harlem. They use our block because Grove is a

cul de sac and to avoid the traffic on Home from cars coming in and out of the parking lot at Roosevelt.

It would make more sense to place a traffic calming device on the 1150 block a 1100 block of Clinton, which drivers appear to view as a clear shot between Roosevelt and Garfield en route to the Eisenhower entrance.

Or, maybe 1100 Clinton should be made a one-way street, like 1100 Grove, the street on which Lincoln School is located. Another possibility would be a traffic calming device in the 900 block of Clinton. Fillmore is also heavily traveled and might benefit from a traffic calming device at Oak Park Avenue.

#### Abstract (briefly describe the item being reviewed):

The Village serves a community of over 52,000 residents within a 4.5 mile radius making Oak Park one of the most dense areas in Illinois.

Over the last several years the businesses growth throughout the community has grown exponentially. Many of these businesses service the community and it's residents with 24 hour care.

Overnight parking is not allowed between the hours of 2:30 am to 6:00 am seven days a week, unless by permit parking allowed or with a temporary overnight parking pass. Several areas throughout Oak Park are also restricted with daytime limits or no parking 8am to 10am to prevent several areas from overcrowding blocks with commuter daytime parking.

Example, owner of MaidPro local Oak Park business located 6901 W. North Ave is a residential H.O.M.E Cleaning service. All staff have their own vehicles and park at different locations in Oak Park throughout the day.

Today, Parking staff would like to begin the discussion regarding potential Parking Permits or Passes for Registered Local Businesses such as discussed above.

#### Staff Recommendation(s):

Start an open discussion with commission on ideas of establishing parking permits or passes for registered local businesses throughout the village who need parking easement privileges to allow their employees to park their business vehicles or personal vehicles during work hours to continue to serve the community and it's residents.

The highlight of businesses would be specifically home cleaning services, delivery services such as FedEx or UPS, general service providers like plumbers, carpet cleaners and construction companies doing work throughout the Village of Oak Park.

My name is Christian Harris. I grew up on the 1100 Block of North Taylor and now reside on the 1200 Block of North Kenilworth. For the past 6 and a half years I have owned the Oak Park Based cleaning service MaidPro Oak Park. Our service provides residential home cleaning services in the Oak Park area. All our staff use their own vehicles to travel to homes in Oak Park. Due to restrictions such as "No Parking 8-10" "2 Hour Parking 9-5" and areas that require permit parking it can be nearly impossible to find parking near our customers homes. As a result we are often forced to risk parking in restricted areas and have received many tickets. Parking in non restricted areas can sometimes mean parking 2-4 blocks away and my staff carries vacuums, buckets, mops, towels and other cleaning supplies. I am writing to ask for you to consider a solution to this issue. This affects businesses like mine, in-home Senior care services, nannies, handymen and more. #### Abstract (briefly describe the item being reviewed):

Currently, the Transportation Commission holds its monthly public meetings on the fourth Monday of the month. In 2018, the Transportation Commission transitioned from a transcription style meeting minutes format to a shorter more condensed meeting minutes format. It was at this time that video recording of the meetings began in order to supplement the new condensed meeting minutes format by providing additional detailed information not found in the condensed meeting minutes. These video recordings are subsequently uploaded to the Village of Oak Park's Commission TV website for public viewing and archiving.

In addition, the Village Board of Trustees has occasion to hold meetings on the fourth Monday of the month at the same time as the Transportation Commission. Both meetings require live-streaming, but the Village does not have the capability to stream them simultaneously. Village Board meetings take precedence over the Transportation Commission meetings. As a consequence, alternate and not always successful means have to be employed to audio record only the Transportation Commission meetings.

Finally, four other commissions in addition to the Village Board regularly video record their meetings. Permanently changing the day of the Transportation Commission meetings to another day not already being used by the Village Board or another commission would ensure that the Transportation Commission meetings could reliably be video recorded on a regular basis.

#### Staff Recommendation(s):

(1) Permanently change the meeting date of the Transportation Commission to the second Wednesday of the month from the current fourth Monday of the month. (2) Start this on Wednesday, March 11, 2020. (3) Cancel the Monday, February 24th Transportation Commission meeting due to its twelve day proximity to Wednesday, March 11th.

The purpose of this agenda item is to discuss, and ideally implement, permanently changing the day of the Transportation Commission meeting to the second (2nd) Wednesday of the month from its current fourth (4th) Monday of the month. This change could take place as early as Wednesday, March 11th. The meeting start time and room would remain the same at 7:00 PM and in the Council Chambers of Village Hall.

There are two primary advantages to permanently changing the meeting day. First, changing the day of the Transportation Commission meetings to another day not already being used by the Village Board or another commission would ensure that the Transportation Commission meetings could be reliably video recorded on a regular basis. Second, changing the meeting day to the second Wednesday of the month would eliminate the annual need to cancel and/or reschedule the current November and December meeting days which often times fall within the Thanksgiving Day and Christmas Day holiday week timeframes.

Transportation Commission Trustees Liaison Buchanan, Village Manager Pavlicek, and Staff support permanently changing the meeting day from the current fourth Monday of the month.

Some background information follows.

Currently, the Transportation Commission holds its monthly public meetings on the fourth Monday of the month. In 2018, the Transportation Commission transitioned from a transcription style meeting minutes format to a shorter more condensed meeting minutes format. It was at this time that video recording of the meetings began in order to supplement the new condensed meeting minutes format by providing additional detailed information not

found in the condensed meeting minutes. These video recordings are subsequently uploaded to the Village of Oak Park's Commission TV website for public viewing and archiving.

The Village Board of Trustees has occasion to hold meetings on the fourth Monday of the month at the same time as the Transportation Commission. Both meetings require live-streaming, but the Village does not have the capability to stream them simultaneously. Village Board meetings take precedence over the Transportation Commission meetings. As a consequence, alternate and not always successful means have to be employed to audio record only the Transportation Commission meetings.

The Village of Oak Park government strives for openness and transparency in its operations and dealing with its citizens. This is good government. Video recording the Transportation Commission meetings provide an additional means for allowing Village residents to visually see and hear its government in action.

The Village does not have the resources to stream/archive all commission and committee meetings. However, it does have enough resources to regularly stream/archive those commissions and committees that have the most impact on the lives of its citizens. These commissions and committees include the Plan Commission, Historic Preservation Commission, Community Design Commission, and Zoning Board of Appeals. The Transportation Commission is among the Village's committees that impact a lot of citizens.

In 2018 when the meeting minutes format transition was taking place, the Transportation Commission members at the time expressed concern about the loss of information that was occurring due to the transition. The comments, thoughts, and reasons of individual members were no longer being recorded and the Commission's detailed discussions involving who said what was not being captured. In addition, some of the members expressed concern because there were occasions when an agenda item review took several meetings and months to complete. The transcription style meeting minutes, unlike the condensed meeting minutes, allowed Commission members to go back and review detailed discussions from previous meetings. Video recording the meetings provide an alternate means to go back and review detailed discussions from previous meetings.

Staff developed some questions that might be asked during tonight's discussion. Following are the questions and answers as provided by Village Clerk Vicki Scaman and other Staff.

- Q1. What day or days of the month, other than the 4th Monday of the month, is the Council Chambers regularly available to hold Transportation Commission meetings starting at 7:00 PM?
- A1. 1st choice = 2nd Wednesday of the month and 2nd choice = 4th Wednesday of the month
- Q2. The Village's Media Production Manager needs to confirm that he can video record the meeting on these days.
- A2. The Media Production Manager prefers the 2nd Wednesday of the month
- Q3. The Trans Com has occasion to meet twice in the same month. What other day or days would regularly be available for this second meeting? (the Commission currently meets on the second Monday of the month when an additional meeting is required)
- A3. 4th Wednesday of the month
- Q4. What are the mechanics of changing the meeting day? Whose approval is required? What notice needs to be given and to whom?
- A4. Notice of change in a regular meeting schedule must be posted at Village Hall and in the local paper at least 10 days in advance of posting for the relevant meeting. The Village Clerk's Office creates the notice to the paper and posts at Village Hall. As far as "whose approval is required", the VCO does not make the schedule, that is between you, your supervisors and the commission.
- Q5. If the Commission recommends the change, does the recommendation have to be presented to the Village Board of Trustees?
- A5. No, your Trustee Liaison should be looped into the discussion as a courtesy.
- Q6. What happens if some or most of the current Trans Com members oppose the idea?

- A6. The change is not practical if you are not likely to have a quorum on most occasions.
- Q7. What happens if some or most of the current Trans Com members conceptually support the idea but are not available on the alternate meeting day or days? A quorum might not be possible.
- A7. Any commissioner who determines the need for a change is valid and beneficial to the role of the commission but they themselves are not able to make the change then they should respectfully resign.
- Q8. How soon after an alternate day is proposed and approved can the change be implemented?
- A8. Considering the notice needs to be in the paper 10 days before you post an agenda at least 2 weeks.
- Q9. Due to audience size and video recording capabilities, room 101 is the only viable alternative to the Council Chambers. Given this, would room 101 be available on the alternate day or days if it's needed by the Trans Com?
- A9. yes

#### Conclusion:

Based upon the above, Staff is recommending the following:

- (1) Permanently change the meeting day of the Transportation Commission to the second (2nd) Wednesday of the month from the current fourth (4th) Monday of the month.
- (2) Start this on Wednesday, March 11, 2020.
- (3) Cancel the Monday, February 24th Transportation Commission meeting due to its twelve day proximity to Wednesday, March 11th.

The Village Board of Trustees did not review any Transportation Commission recommendations at its November 25th through December 5th meetings. The December 5th meeting was its last meeting of 2019.
